

ELIGIBILITY/ENTRY REQUIREMENTS

1. Sea service plus proof of experience maneuvering and handling a vessel over 7.5m

- Record of sea service form 771 (at least 80% of the AMSA sea service requirements).
- 360 days of sea service on vessels at least 7.5 metres long (80% is 288 days)
- At least half on commercial vessels
- Up to half on recreational vessels

Or

- The on-board sea service record from your task book (at least 80% of the AMSA sea service requirements)
- 120 days of sea service on vessels at least 7.5 metres long (80% is 96 days)
- All hours on commercial vessels

And

- A letter from vessel operator, owner, master, or chief engineer detailing your deck and engineering sea service and vessel maneuvering experience of vessels greater than 7.5m

2. Industry experience

- Have held a MAR20521 Certificate II in Maritime Operations (Coxswain Grade 1 Near Coastal) for more than 6 months and supply a letter from a vessel operator, owner, master, or chief engineer detailing your deck and engineering sea service and vessel maneuvering experience of vessels greater than 7.5m

Or

- Have held a Mar10220 Certificate I in Maritime operations (General Purpose Hand Near Coastal) for more than 12 months and supply a letter from a vessel operator, owner, master, or chief engineer detailing your deck and engineering sea service and vessel maneuvering experience of vessels greater than 7.5 metres.

- To ensure you have the right skills and support to succeed in your course, a Language, Literacy, and Numeracy (LLN) evaluation helps identify any areas where you may require additional support to help you achieve your goals.
- Due to physical requirements of this qualification the Learner must be physically fit.

LICENCING/REGULATORY INFORMATION

This qualification is required to obtain an AMSA certificate of competency as a Master <24 metres NC as defined in Marine Order 505

AMSA certification of competency will require:

- Achieving MAR30921 Certificate III in Maritime Operations (Master <24 m Near Coastal)
- A Marine Radio Operators Certificate of Proficiency

Sea service requirement

With AMSA approved task book:

At least 120 days qualifying sea service on a commercial vessel
≥7.5 m long working in a deck capacity

Without AMSA approved task book:

At least 360 days qualifying sea service on a vessel ≥7.5 m long
(of which at least half must be on a commercial vessel), working
in a deck capacity or working both in a deck capacity and an
engineering capacity

- Meeting the medical and eyesight requirements specified in Marine Order 505
- Assessment by an AMSA approved assessor using the AMSA mandated practical assessment (AMPA) conducted on a commercial vessel ≥7.5 m in length.
